Mediator Style & Process My approach to mediation is to spend almost as much time in advance of the mediation date as on the day of the mediation session. I work with counsel in advance to narrow the issues, explore obstacles and develop avenues for potential settlement. This includes my own questionnaire to ferret out personal and cultural contexts, and other factors that can influence settlement. I believe in full engagement of the parties. If a matter does not resolve by the end of the mediation session, I am persistent afterward by contacting counsel periodically to see whether there is a potential avenue for resolution.
