**Mediator Experience** 

Handle deep, intractable, and complex litigated and non-litigated disputes involving high emotions and high dollar amounts. These matters generally involve family business disputes (100+), employment disputes (100+), partnership dissolutions (professional, commercial, and real estate

100+), corporate buyouts, restructures, and dissolutions (100+), trade secrets/intellectual property disputes (30+), and general commercial, business, and real estate matters 800+). Have also mediated construction disputes involving design professionals, general contractors, subcontractors, owners and sureties. Construction matters have ranged from large industrial to commercial to design defect to residential construction defect matters (300+).

## **Representative Issues** Handled as a Mediator

Business dissolution issues include business valuation, buy-out terms, performance, contract interpretation, covenants not to compete, trade secrets. Employment issues included sexual harassment, discrimination, ADA, retaliation, age discrimination, termination for cause, against public policy, etc. Construction issues include delay damages, change orders, design defects, indemnity, interference, failure to perform, interference, delays, weather issues, construction or material defects. Trade secrets issues include misappropriation of trade secrets, breach of confidentiality. Real estate issues have included easements, boundaries, rights of way, breach of sales contract, escrow issues, title issues of all types, adverse possession, water rights, damages, restitution, appraisals, specific performance, and injunctions. Family business issues have included buy-out negotiations, restructures, trust building, respect agreements, reconciliation of injustices, retirement, financial security, business dissolution, family reconciliation. Restorative justice cases include clergy sexual abuse (3) and criminal matters (150) ranging from vandalism to aggravated assault with serious bodily injury.

# **Preferences**

Mediator Style & Process I view mediation as a process about choices. My role is to provide a safe, secure, confidential process where the parties can have the difficult conversations necessary for resolution, that they are unable to provide for themselves. I prefer no-caucus mediations, but will utilize caucus as necessary. because of my additional graduate training as a peacemaker, I see most conflicts in a broader perspective than as a legal dispute. consequently, i help the parties seek pragmatic, creative, business, and personal solutions that would be unavailable from a court. Ideally, i hope and expect the parties to participate fully in the process and for counsel to be counselors and advisors instead of advocates.
