Mediator Style & Process Preferences	I approach mediation as an opportunity to resolve all or part of disputes by getting both parties to understand the value of both their and the other parties' claims, issues, or disputes, understand not just the apparent costs but the indirect costs of distraction, consultants, and lost time and opportunity if resolution is not achieved. I see mediators as facilitators who, if qualified in the particular dispute area, can help both parties clarify the facts of their positions, bring reality to their arguments, and

	move beyond the emotions of the issues. It is the mediators responsibily to encourage the parties to reasonable accomodation, but not to force resolution.
