Mediation invariably results in new information, clarification of issues and focuses the parties on resolution. Mediation is overwhelmingly successful with over 95% of cases resolving at mediation or within a short time after mediation. The keys to successful mediation are willingness to participate, commitment to the process and preparation, both legal and personal, to find a solution. The mediator's main role is to facilitate communication and persistence in pursuing settlement.
