The mediator must listen to each party without preconception of the merits, understand each party's interests and claims, evaluate with each party the strengths and weaknesses of each party's claims and defenses, and offer analysis of the best, worst and most likely outcomes at trial, including the litigation costs. The mediator must patiently and diligently move the parties from positional bargaining into meaningful and principled concessions and, ultimately, settlement. The parties must share necessary information prior to the mediation concerning both the merits and damages, and frequently will need preliminary expert reports, in order to make the mediation successful.
