participant. It is critically important that the mediator be able to quickly "issue spot" and identify the primary issues that are hindering resolution. A mediator must also be patient, while also encouraging patience in the participants. Participants in the mediation should be prepared and understand not just

their strongest arguments, but also their weaker arguments.
