It is important to remind the parties that we are here to resolve the matter, and focus not on how weak the opposing sides' case may be, but how strong your case is; then we find a way to meet somewhere in the middle.

Mediation provides a means for all parties to resolve issues without either party having to make a total sacrifice; mediation is about finding a middle ground to resolve a dispute, without the expending as much of the cost, time and energy it would take in court proceedings.
