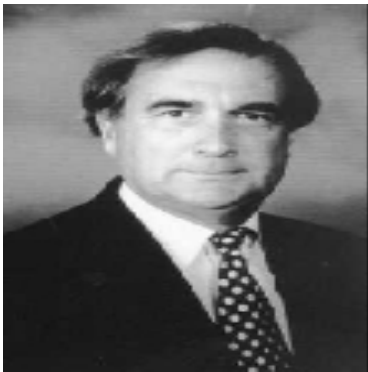

Then, to provide an environment for free exchange of shuttle diplomacy among the parties by the mediator with occasional encouragement toward settlement by emphasizing risks to the parties at trial, either before a judge or a jury. Allowing sufficient time for these discussions to proceed to finally conclude with a compromised agreement.
