Has a general business related practice and handled everything clients needed, from contracts, real estate matters, dissolution of marriages, preparation of wills, estates, or other matters when needed. Also had a large appellate practice for business clients.

Representative Issues Handled as a Mediator

Flooding was result of a defective product. Insurance company paid out a large amount of damages and then filed subrogation claim against manufacturer's insurance. Defense was that product was defective, and the alternative defense was that damages were paid that were excessive, or not a proximate result of the flooding.
