Mediator Style & Proces Preferences	s I typically reach out separately to the attorneys for each party in advance of the mediation. I spent 33 years litigating cases, and have great respect for the work that litigators do. I ask for background about the case, and get to know each of the attorneys. These calls allow me to structure the mediation in a manner that meets the needs of the parties.
	I encourage parties to exchange information in advance of the mediation, including the basis for damage calculations, and key documents and information that support their claims and defenses.
	I take the time necessary to understand each party's position, and how their interests can be served through a settlement. Confidentially is an essential pillar of mediation, and I do not share information provided to me in private caucuses unless authorized to do so by the party providing the information.
	I work with each party to develop realistic settlement proposals that address the needs and interests of all parties. I also act as a sounding board. I generally do not share my view of the likely outcome of the case. However, in a private caucus and at later stages in the mediation, I may share my views regarding specific issues if requested to do so by the parties, and if I believe this information will facilitate settlement.
	I find that Zoom works very well for conducting virtual mediations.
