In my experience, mediation can be more efficient, saving time, expenses, and offers options in a

	resolution that the Court cannot sometimes achieve for the parties. Facilitating communications between the parties and sometimes in even assisting the parties in exploring creative solutions resulting in a win-win outcome. Mediation is a process that takes time and the parties who understand that usually helps with a positive resolution. Even in those cases where it will not settle, I find that the parties learn about their case, where the other side is coming from and leaving the door open for the potential that it can still be resolved with or without the mediator. Throughout the process showing respect for the parties and their counsel is very important. Differences always exist but, building bridges and forbidding lines being drawn in the sand is what a mediator tries to do.
