AMERICAN DISABILITIES ACT (ADA):

Lawsuits regarding a wide range of alleged accessibility issues and architectural barriers at various types of business establishments open to the public, including nursing homes, care facilities, hotels/motels, medical/dental offices, restaurants, fast-food locations, gas stations, retail stores (including luxury stores), shopping malls, grocery stores, and small/local businesses.
