Mediator Style & Process Preferences	Studies show that the most successful mediators are those who develop a rapport with mediation participants, and the most satisfied parties are those who have prepared well for mediation. I strive to achieve these goals by carefully implementing specific behaviors to engender trust and confidence in the mediator and by working with mediation participants in advance of the mediation session. Since mediator style is not the best predictor of successful mediations, I offer a 360-degree style by suggesting ideas for mediation preparation, facilitating communication and creative ideas, and serving in a directive capacity as needed. As a nationally recognized expert regarding mediation ethics, I help parties in conflict to communicate in a positive manner regarding sensitive issues. I have a reputation for fairness and professionalism, and bring a people-centered approach to each mediation by exhibiting such behaviors as patience, perseverance, and perpetual optimism.
