Mediator Style & Process Preferences	Relentless pursuit of resolution with the overarching goal of avoiding the inherent uncertainty, expense, and frustration of the courthouse, while maintaining high ethical standards that preserve the integrity of the ADR process. Initial focus is to obtain a deep understanding of the parties' needs (financial, emotional, tangible and intangible) as well as an understanding of each side's position (factual, legal, and other relevant factors, such as leverage). If necessary, facilitate the exchange of information pre-mediation to ensure each party has sufficient knowledge to develop an informed position on settlement. During mediation, engage in extensive risk-analysis, primarily through neutral, non-adversarial questioning and reality-testing, to help the parties evaluate the strengths and weaknesses of their own case, as well as that of their opponents. Facilitate resolution by encouraging the parties to evaluate proposals based on a reasoned examination of the pros and cons of settlement.
